MINUTES

1. Call to Order/Roll Call – 6:36 p.m.

RFA Chair Barbara Pierce called the meeting to order. CEO/General Manager Nicole Sandkulla called the roll. Seventeen (17) members of the board were present at roll call, constituting a quorum. One member of the Board arrived after roll call. A list of directors present (17), vacant (2), and absent (8) is attached.

2. Special Order of Business – Election of Officers for Calendar Year 2020: Chair Pierce called for nominations for the position of Chair of the RFA Board. Director Quigg nominated Barbara Pierce for Chair, seconded by Director Mendall. There being no other nominations, nominations were closed by consensus.

The Board unanimously voted to elect Barbara Pierce as Chair of the San Francisco Bay Area Regional Water System Financing Authority for calendar year 2020 to commence at the adjournment of the meeting at which she was elected.

Chair Pierce called the nominations for the position of Vice-Chair of the RFA Board. Director Cormack nominated Gustav Larsson for Vice-Chair, seconded by Director Chambers. There being no other nominations, nominations were closed by consensus.

The Board unanimously voted to elect Gustav Larsson as Vice-Chair of the San Francisco Bay Area Regional Water System Financing Authority for calendar year 2020 to commence at the adjournment of the meeting at which he was elected.

- 4. Consent Calendar:

Director Quigg made a motion to approve the Consent Calendar.

Director Cormack asked what the excess legal expense was.

Ms. Sandkulla explained that a legal analysis was done for Director appointments, particularly two RFA Directors, whose appointments were for an indefinite period. The analysis recommended the appropriate process that must be completed by the appointing agency to fulfill the legislative requirements. Director Cormack seconded the motion, to approve the minutes of January 17, 2019, and to adopt the FY 2019-20 Budget of \$1,650. The motion passed unanimously.

- 6. General Manager's Report: Ms. Sandkulla reminded the Board that the Annual FPPC Form 700 Filing for FY 2019-20 are due by April 1, 2020. An email notice will be sent via BAWSCA's electronic filing system.
