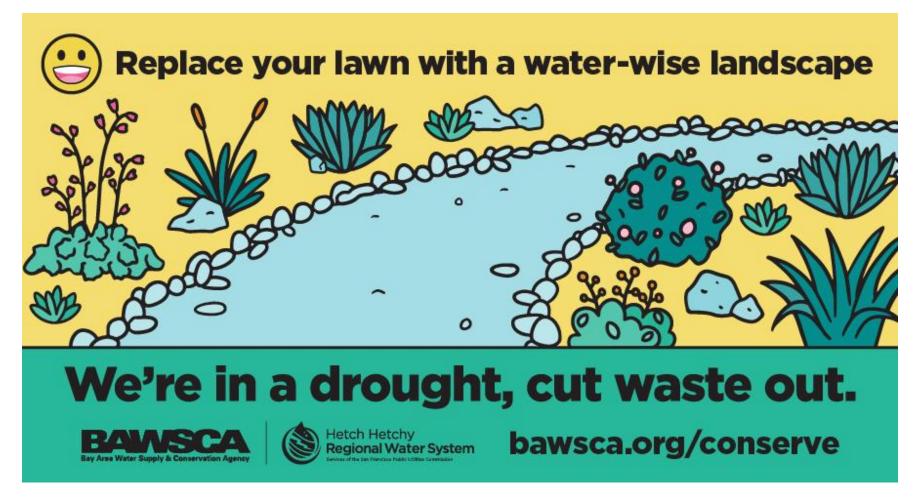

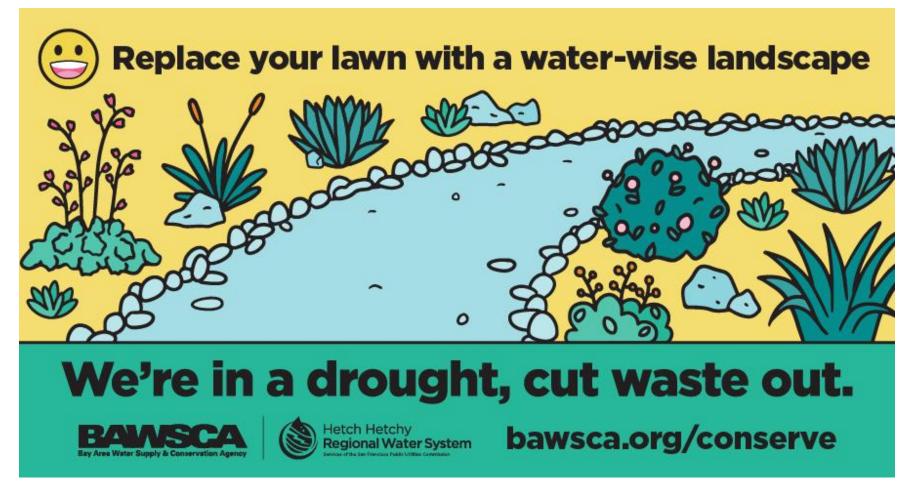

Annual Review and Consideration of BAWSCA's Statement of Investment Policy





Annual Review and Consideration of BAWSCA's Investment Policy

- BAWSCA's Investment Policy requires annual review of the <u>Statement of Investment Policy</u>
 - Primary objectives: safety, liquidity and yield
- Last reviewed in November 2021
 - No changes made
- Both agency funds and bond funds are invested per Investment Policy
 - Most agencies have the Policy govern operating funds, not bond funds
 - Permitted investments reflect the agency's circumstances and primary investment objectives
 - Current language is consistent with State law
- No changes to the policy are recommended

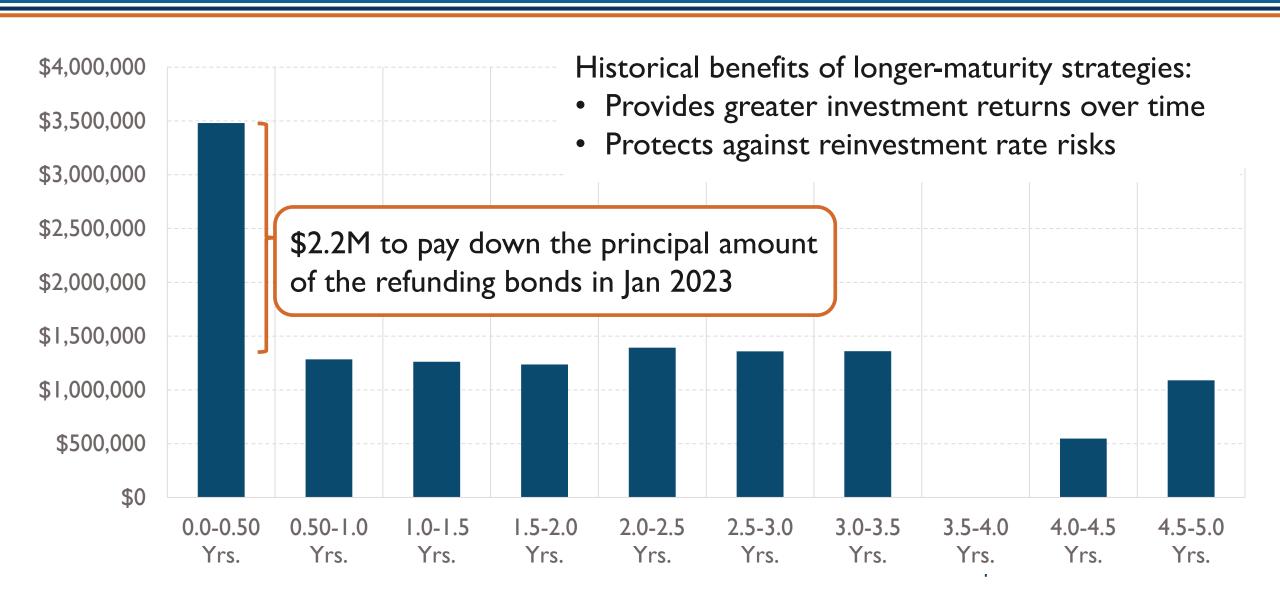


Overview of Investment Strategy for Bond Stabilization Fund

- Federal Reserve has continued raising interest rates in response to elevated inflation since the beginning of 2022
- BAWSCA's longer-term portfolio strategy is performing well
 - Continues to provide important yield curve diversification against both market price and reinvestment rate risks
- Total bond funds held by Trustee: \$16,772,247 (as of 10/5/2022)
 - \$3.8M bond surcharges in Money Market Fund
 - \$13.0M stabilization fund in U.S.Treasury Securities
- Based on a recent evaluation, the current 0-5 year laddered maturity investment strategy is determined appropriate

Adoption of Resolution #2022-11 Approving the Extension of the 2021 Amended and Restated Tier 2 Drought Response Implementation Plan





Drought Shortages on Regional Water System Governed by Two Plans

- Tier I Plan Allocates water between SFPUC Retail Customers and the Wholesale Customers collectively
- Tier 2 Plan (or DRIP) Allocates water among the Wholesale Customers
 - Adopted in the Winter/Spring of 2011 by the governing body of each Wholesale Customer.
- Tier I and Tier 2 Plans apply during system-wide shortages of 20 percent or less
- WSA Section 3.11(C)(3): SFPUC will honor Tier 2 allocations among the Wholesale Customers provided by BAWSCA or unanimously agreed to by all the Wholesale Customers.



Tier 2 Plan Originally Expired December 31, 2018

- Tier 2 Plan term was through December 31, 2018
 - Consistent with timing of SFPUC 2018 decisions per 2009 WSA
- WSA enables BAWSCA Board to extend the Tier 2 Plan
 - Per WSA Section 3.11(C)(3)
- May 2019: BAWSCA Board approved a 1-year Plan extension through Dec. 31, 2019
- Nov. 2019: BAWSCA Board approved a 1-year Plan extension through Dec. 31, 2020
- Nov. 2020: BAWSCA Board approved a 1-year Plan extension through Dec. 31, 2021
- Nov. 2021: BAWSCA Board approved a 1-year Plan extension through Dec. 31, 2022
- The Water Management Representatives (WMR) have been engaged and supportive of the Tier 2 adoptions by the Board for each of the successive years
 - Appropriate to delay renegotiations of new Tier 2 until State efficiency requirements known



BAWSCA is Facilitating Negotiations Between the WMR to Update the Tier 2 Plan

- In January 2022, BAWSCA and the member agencies initiated an update to the Tier 2
 Plan
- Each agency appointed a lead negotiator to represent their agency's interests and perspectives
- Agencies have agreed to a set of policy principles to guide model development
- Between January and August 2022, negotiations were held during monthly WMR meetings in a remote setting
- In-person meeting began in September to supplement discussions at monthly WMR meetings
- BAWSCA is encouraged by the productive discussions and progress made to date
- However, it is not feasible to finalize an updated Tier 2 Plan and have all member agencies adopt it by the end of the calendar year



Current Implementation of Tier 2 Plan

- In November 2021, SFPUC declared a water shortage emergency, triggering implementation of the Tier 1 and Tier 2 Plans for the first time
 - During 2015-2017 drought, Governor Brown mandated water use reductions across the state, superseding the Tier 1 and Tier 2 Plans
- Given that the SFPUC's November 2021 drought emergency declaration remains in effect and the Tier 2 Plan is currently being implemented, it is recommended that the Board extend the term of the 2021 Amended and Restated Tier 2 Plan



Recommended Action

That the Board Policy Committee recommend Board adoption of Resolution 2022-II extending the term of the 2021 Amended and Restated Tier 2 Plan through December 31, 2023.

BAWSCA Initiating Update to Long-Term Reliable Water Supply Strategy

- BAWSCA's Reliable Long-Term Water Supply Strategy (Strategy) last completed in 2015
 - Phase I Scoping Report Published in June of 2010
 - Phase IIA Strategy Report with Recommended Actions Published in June of 2012
 - Final Report Detailed Implementation Plan / Final Strategy Published in February of 2015
- Strategy focused on the implementation of regional water supply projects (desalination, long-term water transfers, etc.) that would provide a BAWSCA-specific water supply to member agencies
- FY 2022-23 Work Plan anticipates initiation of Strategy update
 - Develop a scope for the updated Strategy
 - Consider information developed from BAWSCA's Regional Water Supply Reliability Roundtable
 - Consider result(s) from attempts to implement portions of BAWSCA's existing LTWSS
 - Prepare the updated Strategy 2023-2025
 - Incorporate information gleaned from BAWSCA's updated demand study
 - Incorporate information gleaned from SFPUC's Alternative Water Supply Plan
 - Consider the updated Tier-2 Plan



Strategy Update Scoping Efforts Have Begun

- Information from BAWSCA's Regional Water Supply Reliability Roundtable informs the Strategy Update scope
 - BAWSCA is meeting with individual member agencies to discuss their specific efforts to develop water supply projects
 - Those meetings are on-going and Project Information Forms (PIFs) are being prepared
- BAWSCA developing an RFP to be issued in late 2022 for scoping support
 - BAWSCA has identified that consultant support is required for scope development
 - Consultant support will assist staff in finalizing the scope for the Strategy update, incorporating information from agency discussions (including PIFs)
 - Engagement with Board will continue through BPC and Board presentations and feedback
 - Scope for the Strategy update will be used to develop a formal workplan for moving forward

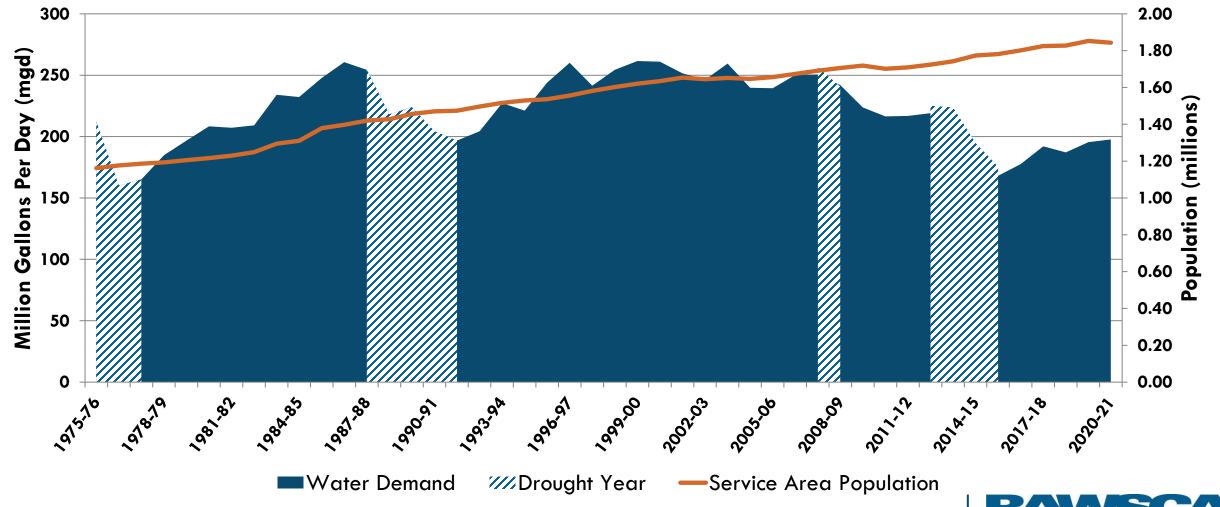




October 11, 2022 Reservoir Storage

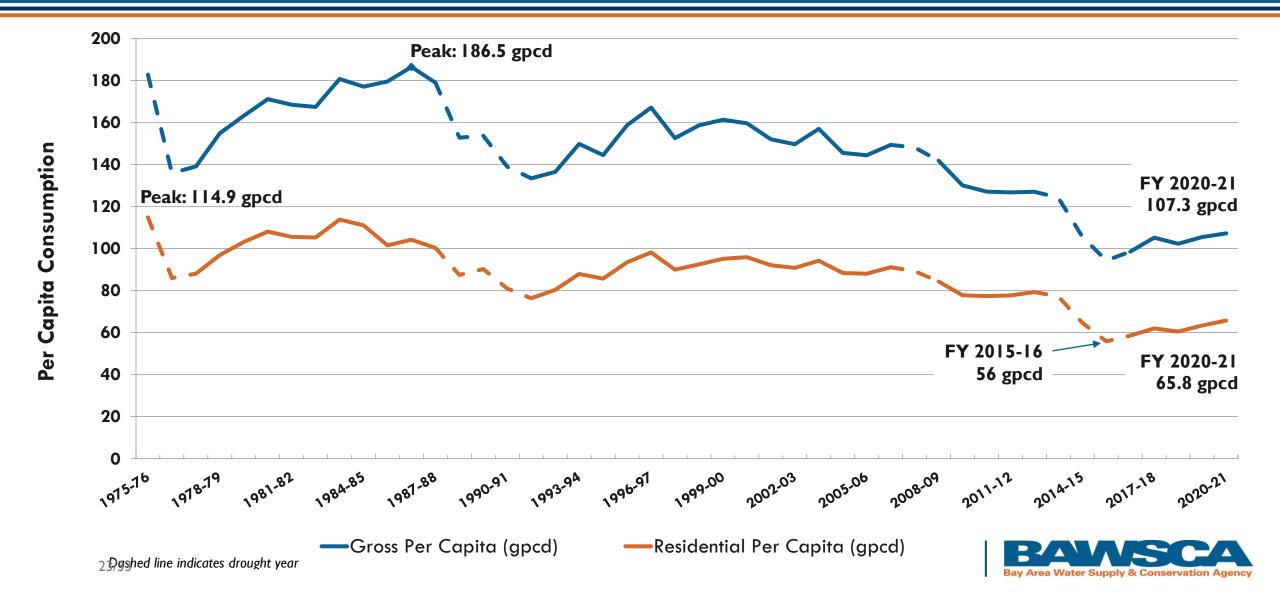

24% Less Water Used Today in BAWSCA Region Compared to FY 1986/87 Despite a 32% Population Increase

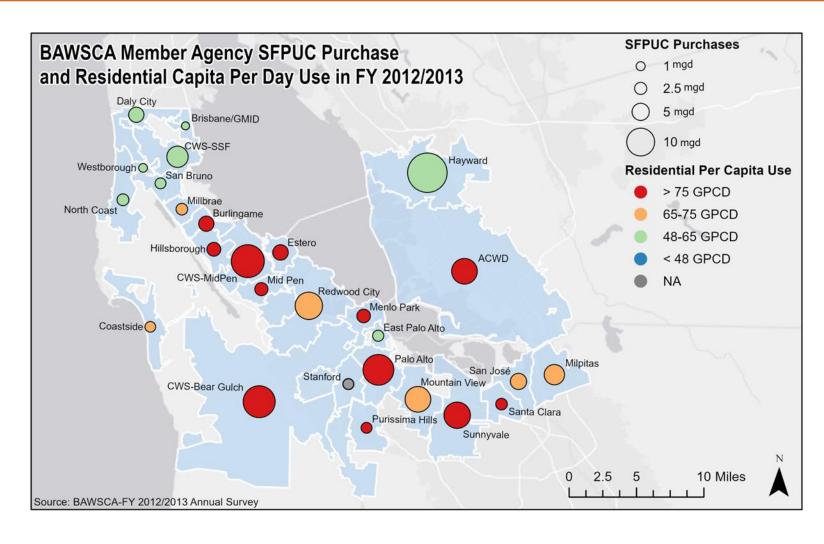




Residential Per Capita Water Use Has Decreased by 37% in BAWSCA Region Since FY 1986/87



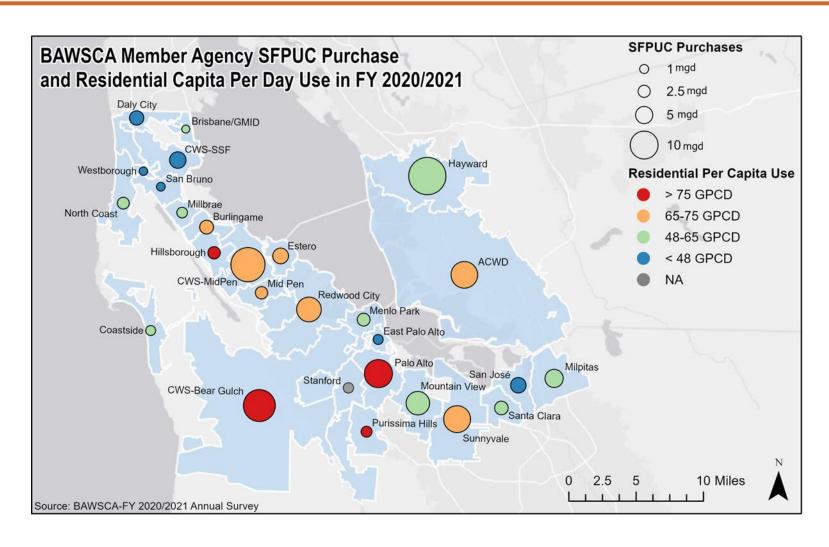
Average Residential Water Use in BAWSCA Region in FY 2012/13 was 71 GPCD

- 49 GPCD SF Retail Residential Use (avg.)



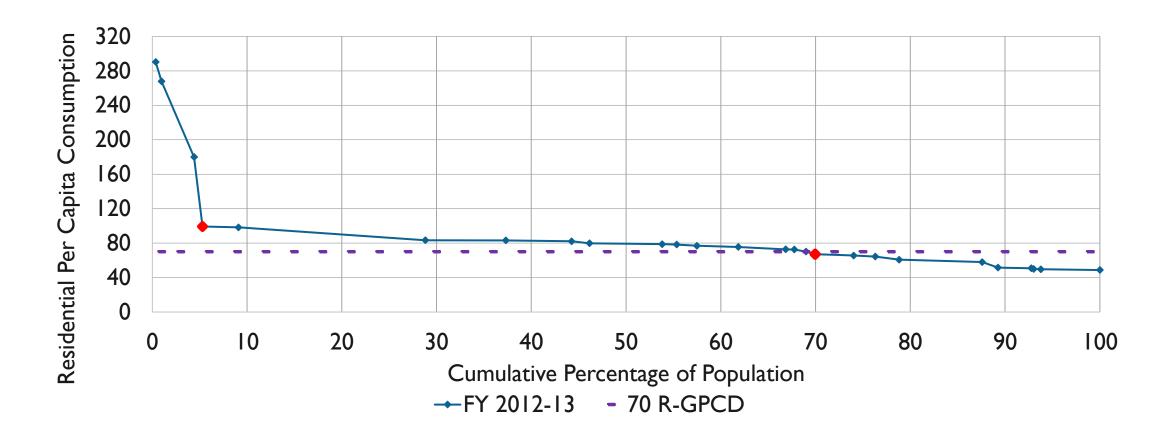
Average Residential Water Use in BAWSCA Region in FY 2020/21 was 66 GPCD

- 42 GPCD SF Retail Residential Use (avg.)



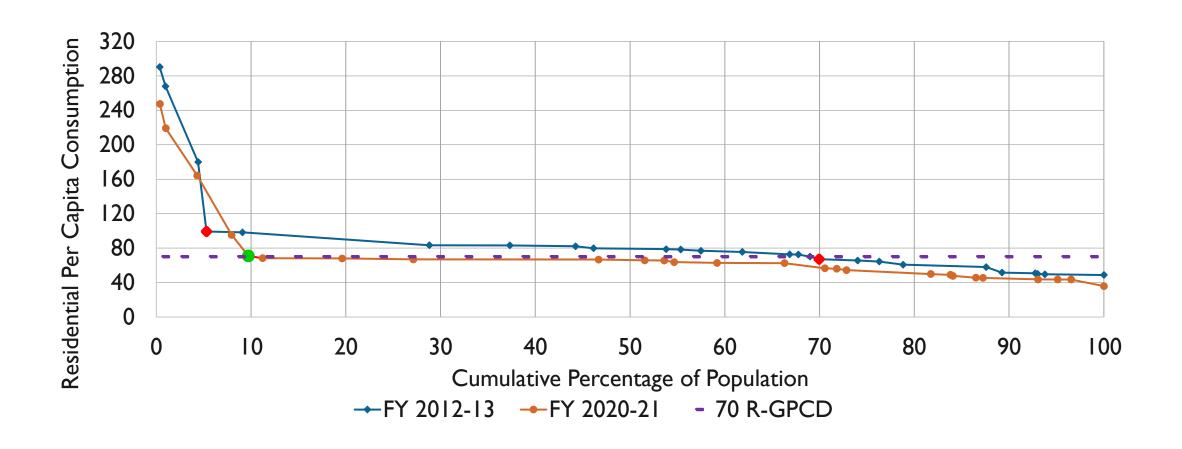
In FY 2012/13, 31% of Water Customers in the BAWSCA Region Used Less Than 70 Gal Per Day





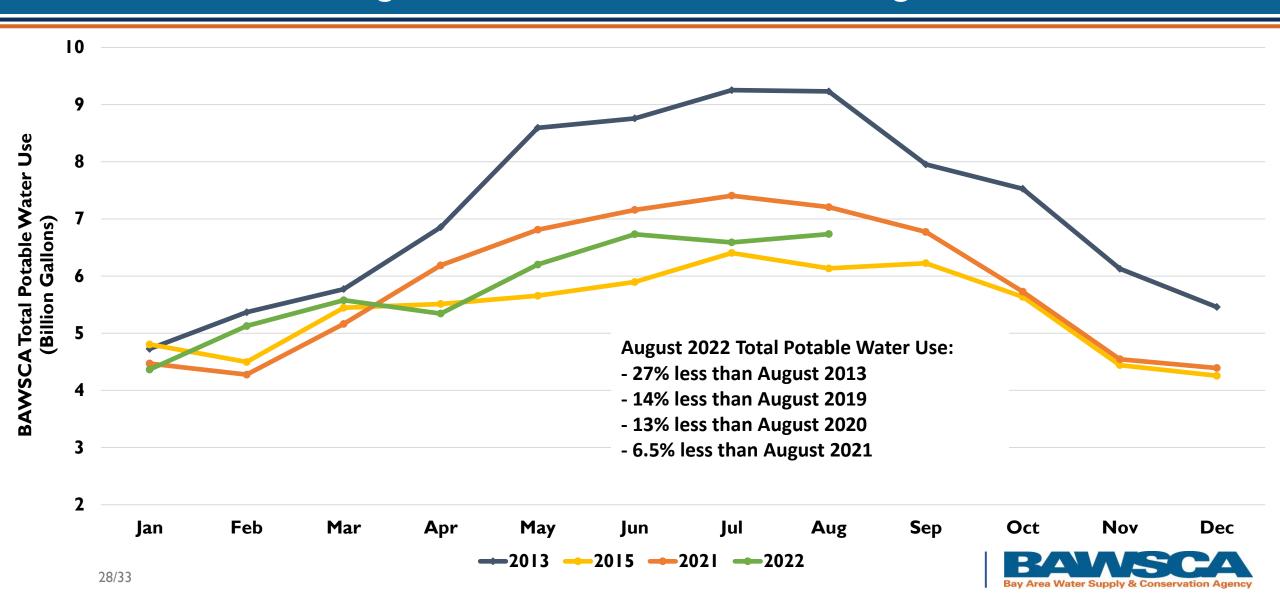

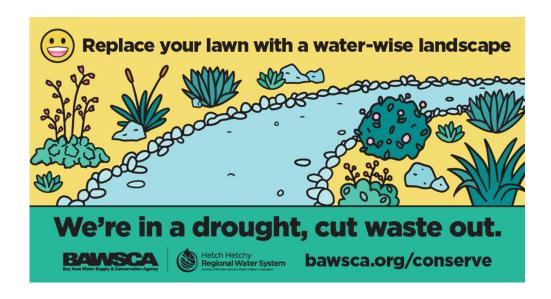


BAWSCA August 2022 Total Potable Water Use 27% Less Than August 2013 and 6.5% Less Than August 2021



BAWSCA Working with Its Member Agencies to Achieve Necessary Water Savings

- BAWSCA and its member agencies are committed to responding to the Governor's and SFPUC's call for water use reductions
- Water customers are responding to the call for increased water conservation
- Aug 2022 water use showed continued savings compared to 2021
- Overall water use (from all sources) down 6.5% in August compared to August 202 I
- Cumulative savings not yet achieving overall RWS target reductions
- What further actions are needed at the water supplier level and regionally?
- BAWSCA will work with the its member agencies and the SFPUC to identify further steps to reduce water use in anticipation of another dry year
- BAWSCA and its member agencies respect the Governor's leadership in responding to the current drought





Bay Delta Plan – Voluntary Agreement Discussions Continue

- State continuing efforts on a Memorandum of Understanding to develop an agreement to protect beneficial uses in the Sacramento-San Joaquin Delta (MOU)
 - First signed in March by State (Natural Resources, EPA, DWR, CDFW) and other large water agencies with interest in Delta (Yuba County Water Agency, Westlands Water District, MWD, State Water Contractors, Kern County Water Agency, USBR, etc.)
 - In mid-August, EBMUD joined as a signatory to the MOU
- The MOU outlines broad areas of agreement (i.e., narrative rather than a numeric objective for the Bay Delta Plan) and anticipates the need for further negotiations among all signatories to develop detailed implementation agreements
- Ongoing dialogue between SFPUC, the Districts and the State about the potential inclusion of voluntary agreement flows for the Tuolumne River in the MOU
- SFPUC, the District, and the State to continue to work toward a mutually agreeable MOU

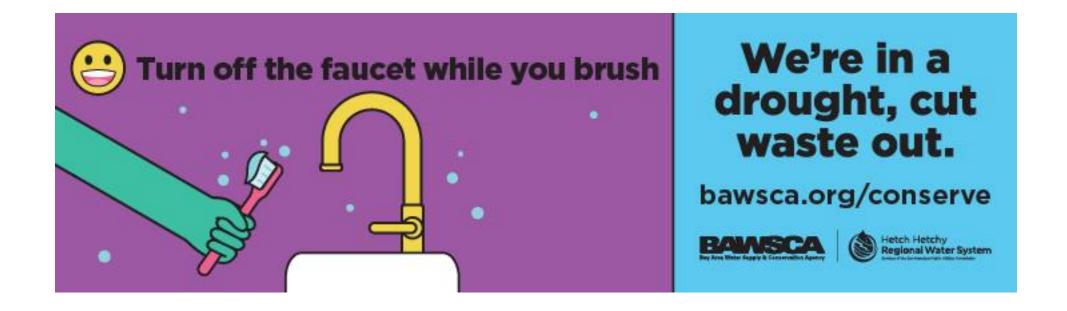
